Hay: Apply 1.3 ounces of PRO-SERVE per one ton of dried cut forage. Apply to small, square bales (40 to 100 pounds) of no more than 24% moisture and to large round or square bales up to 20% moisture. Spray PRO-SERVE evenly, diluted as needed to deliver the proper rate. For example: mix one part PRO-SERVE to 24 parts water and apply one quart of solution per ton.

Silage or Haylage: Mist PRO-SERVE at a rate of 1.3 ounces per one ton of fresh cut forage. Spray applications may occur at the chopper or blower stages.

Storage: Store under cool, dry conditions. Keep container tightly closed.
