DIRECTIONS FOR USE: Shake well before using. Add the proper amount of Kip Cullers' Nutrient Compass Foliar Fertilizer to the spray tank when it is one-third full of water, finish filling with water and add other chemicals. (Always test for chemical compatibility prior to large-scale mixing.)

APPLICATION GUIDE: Foliar: One to two quarts per acre, see separate Application Guide for crop specific and application timing information. Kip Cullers' Nutrient Compass Foliar Fertilizer can be applied along with fertilizers or in combination with most pesticides. When applied with ground application equipment, use no more than 10 gallons of total spray solution per acre. When applied with aerial application equipment use no more than 5 gallons per acre of total spray solution. A quality wetting agent such as Saturall 85® or Rain-Fast® may be used to ensure even coverage.

MIXING PROCEDURE: To a tank one-half full of water (start recirculating) then add Kip Cullers' Nutrient Compass Foliar Fertilizer. Complete filling of spray tank to desired volume and continue circulating prior to application.

NOTE: If label directions are not followed phytotoxicity may occur. **Foliar fertilization is intended as a supplement to a regular fertilization program and will not by itself provide all the nutrients normally required by agricultural crops.**

HANDLING AND STORAGE: Store out of the sun in an area of moderate temperature. DO NOT store at temperatures over 100° F (38° C) for prolonged periods of time. DO NOT FREEZE. Store in fiberglass, stainless steel, polyethylene or mild steel. Avoid containers, piping or fittings made of copper-bearing alloys or galvanized metal. DO NOT reuse container. Dispose of containers properly after thoroughly flushing with water a minimum of three times. Keep spills from waterways and sewers.
